

COPYRIGHT IN 6 POINTS

- 1) Photographs, drawings, watercolours, lithographs, engravings and postcards are treated as intellectual works. As such, their use is governed by the Intellectual Property Code (more commonly known as **Copyright***).
- 2) There are two sections applying to copyright: that of the rights attached to the person of the author (moral rights) and that of the rights relating to the collection of financial advantages (property rights).
- 3) The perpetual, inalienable and imprescriptible moral right makes it obligatory to mention the name of the author, even after his death, when using a work or a copy of this work.
- 4) The property right authorises any author to be remunerated for every use of his work throughout his life. On his death, this right passes to his heirs or assignees for 70 years, a period after which the work falls into the public domain.

E.g. In 2011 the works of photographers who died after 1941 are therefore not in the public domain.

- 5) Although the Archives Nationales d'Outre-Mer keeps images it does not hold the copyright relating to them. It is, therefore, up to any requester to perform the necessary research and to seek approval from the copyright holder(s) before using the images in our collections.
- 6) An image, for which the author or his date of death is not known, cannot be reproduced for any other purpose than strictly private, non-commercial use. It is not possible to reproduce it for exhibiting, publishing, representation, creation of derived products, etc.
